EDA participates in 'Crafting Transatlantic Green Marketplace' event

The EU-US Trade and Technology Council (TTC) organized a stakeholder event on 31 January 2024 with the aim of helping implement the Transatlantic Initiative on Sustainable Trade (TIST) Work Programme. The event was launched with a high-level

plenary session including policymakers from both sides of the Atlantic. Subsequently, various breakout sessions provided opportunities for stakeholders to engage in focused discussions on strategies to enhance circularity, promote the adoption of environmentally friendly technologies, and ensure a just transition to a clean-tech economy. As a stakeholder in the event, EDA actively participated in the debate on how to make the transatlantic marketplace a key factor for more sustainable and climate-neutral economies on both sides of the Atlantic.

EDA prepares for the next EU Trade Strategy and the CAP-2027

In this week's EDA Trade and Economics (TEC) meetings, our TEC chairs Lise Andreasen Høyer (DDB) and Béranger Guyonnet (Sodiaal) welcomed DG AGRI's Krystian Kęciek and Fabienne Alcaraz.

"We have finalized our EDA CAP-2027 position and made good progress on our EDA input for the next EU Trade Strategy – we really want to see the EU and all Member States acknowledge the importance of trade for our economic base. When it comes to our future trade focus, we decided to analyse in depth the potential of the Thailand and Indonesia markets", stated EDA Director of Economics and Trade Laurens van Delft.

A liberal take on the Future of Agriculture

AGRI-Coordinator MEP **Ulrike Müller** (Renew, DE) organized and moderated a stimulating seminar on the future of agriculture on 14 February. This event, under the flag "A People-driven Agriculture Policy for Europe - What are the Options?", allowed for a comprehensive discussion on the future of European agriculture, with the right mix of politics, policy, and

academia. The seminar included presentations from Professor Peter Feindt (Humboldt University), Professor Goedele Van den Broeck (UC Louvain), Professor Roel Jongeneel (WUR Wageningen), Professor Patrick Caron (Montpellier University), and Professor Dobri Yarkov (Trakia University). Participants discussed a variety of possible scenarios that could shape the future of European agriculture and the EU's rural areas. It seems clear that there is not a one-size-fits-all solution, but sharing best practices and coming together to discuss future scenarios seems like a good start ahead of the next CAP reform.

Conclusion: There is insufficient scientific evidence to support the use of Nutri-Score as an effective public health tool. Overall, the available evidence is limited and biased.

limited and biased, and more research is needed to substantiate or disprove the effectiveness of Nutri-Score.

The publication of the article is accompanied by an interesting interview with Dr. Stephan Peters in "Nutrition Insight": Is Nutri-Score misleading? New research advocates for rigorous independent testing where he highlights that the system should be evaluated by independent scientific food authorities for real-life evidence of its benefits for the consumers.

As EDA, we strongly believe that Nutri-Score fails to align with European Food Based Dietary Guidelines - especially for milk, liquid dairy products and cheeses. Find out more in our recently published EDA Position Paper on Nutri-Score.

EU Dairy in New Delhi

EU Commissioner for Agriculture Janusz Wojciechowski visited New Delhi in India from 6 to 12 December 2023, accompanied by a business delegation of senior representatives from the EU agrifood sector. EDA secretary general Alexander Anton represented the European dairy sector in Asia's biggest milk-producing country. The visit came at an excellent time, as the EU and India are currently negotiating a Free Trade Agreement.

"Dairy plays a significant role in both the EU and India, this counts for numerous aspects including cuisine, culture, and the economy. Concluding these trade negotiations successfully will be a win-win situation for both parties", stated Alexander Anton.

EDA attends event on 'Food Loss Technologies and Policies'

On 13 February 2024, EDA had the pleasure to attend the "Advancing Food Loss Technologies and Policies" event organized by Competere and Trane Technologies. This important event was hosted by MEP Rosa D'Amato (Greens/EFA, IT) and provided an overview of technical and policy developments regarding food waste and food loss. The event was an occasion for a meaningful dialogue between EU MEPs and industry members representing retailers, new technology developers as well as trade associations with additional insights provided by Alexandra Nikolakopoulou (Head of Unit, Farm to Fork Strategy, DG SANTE). EDA welcomes the provisional agreement on the 'Breakfast Directives'

On 31 January 2024, the European Parliament and the Council of the EU announced a provisional agreement concerning four of the so-called 'Breakfast Directives'. The revision of these policies will update the rules concerning the composition, labeling, and naming of certain foodstuffs. When it comes to milk, the revised directives introduce simplified labeling for milk: the distinction between 'evaporated' and 'condensed' milk will be removed, in line with the Codex Alimentarius standard. Lactose-free dehydrated milk will also be authorized.

EDA welcomes the agreement reached by legislators and will continue to advocate for a sustainable, responsible, and consumer-friendly dairy sector.
